

Proposed Project: The applicant is proposing to demolish four residential structures located on four separate parcels and develop a 70-stall parking lot with landscaping. The new parking lot will augment the existing parking lot that currently serves the residents of the existing Huntington Westminster Senior Housing facility. The project also includes vacation of a portion of a public alley to accommodate the new parking lot. Tentative Parcel Map is requested to consolidate four parcels and an alley into a single 0.33-acre parcel. Additionally, the project entails a request for a zone change from R1 (Single-Family Residential) zone to R1-P (Single-Family Residential-Parking Overlay) which would facilitate the development of the proposed parking lot.

Environmental Review Status: An initial study and a draft mitigated negative declaration (MND) have been prepared for the above referenced project. Pursuant to the California Environmental Quality Act (CEQA) and the City's Guidelines for the Implementation of CEQA, the City has analyzed the project and determined that the project as proposed does not present a threat of significant impacts to the environment. The public review period for the Initial Study was previously noticed and ran from September 12, 2017 to October 2, 2017. The Initial Study and proposed Mitigated Negative Declaration have remained available for public review at City Hall, the


